## DCX SUBSCRIBER AGREEMENT

This Subscriber Agreement (this **Subscriber Agreement**) is entered into and made effective as of the date indicated on the attached *DCX Purchase Order Form* when signed and accepted by ISENTRY and shall be by and between: (1) **ISENTRY LIMITED**, a company incorporated with limited liability in England and Wales, whose registered office and address for notices under this Subscriber Agreement is at 8 John Street, London, WC1N 2ES (**ISENTRY**, and which expression shall include, where the context permits, its successors and assigns and affiliates); and (2) **THE PARTY** whose name and address and respective particulars with respect to this Subscriber Agreement are set out in the attached *DCX Purchase Order Form* forming part of this Subscriber Agreement (the **Subscriber**).

### MAIN OPERATIVE PROVISIONS

#### I Introduction

The purpose of this Subscriber Agreement (**Subscriber Agreement**) is to set out the terms and conditions on which ISENTRY will provide to the Subscriber access to of the ISENTRY Services with support services and as particularised in the *DCX Purchase Order Form* (the **iSentry Services**); and the Subscriber agrees to accept the iSentry Service upon such terms and the conditions as set out in this Subscriber Agreement and the Subscriber User Documentation referred to below. This Subscriber Agreement shall include the documents attached or incorporated by reference or otherwise and published on the iSentry website at [www.isentry.com](http://www.isentry.com) (together, the **Subscriber User Documentation**) and which together, with this Subscriber Agreement and the *DCX Purchase Order Form* shall form the entire agreement between the parties. In this Subscriber Agreement, words and expressions defined in the *Licence and Support Conditions* and the *General Conditions* (as published on the iSentry website [www.isentry.com](http://www.isentry.com)) shall have the respective meanings given to them when used throughout this Subscriber Agreement and the Subscriber User Documentation; and otherwise words and expressions appearing in lower case bold font shall have the respective meanings given to them in the context in which they first appear. Headings are for convenience only and shall not affect the construction of this Subscriber Agreement.

#### II iSentry Services and their Use

In consideration of the payment of the Subscription Fees as provided for in the *DCX Purchase Order Form*, ISENTRY agrees to provide to the Subscriber User the iSentry Services and to provide support services detailed herein.

#### III iSentry Service Fees

The supply and Use of the iSentry Services is subject to and conditional upon payment of the iSentry Service Fees as set out in the *DCX Purchase Order Form* and as otherwise provided for in the *General Conditions*.

#### IV Territory

The territory or territories (**Territory**) to which the Use of the Licensed Products shall be subject for the purposes of this Subscriber Agreement and the Use of the iSentry Services shall be in and from the **United Kingdom** or as may be otherwise specified in the *DCX Purchase Order Form*.

#### V Termination

This Subscription Agreement shall continue in full force and effect for the term as provided for in the *DCX Purchase Order Form*, unless terminated prior thereto either in accordance with the *Licence and Support Conditions* or the *General Conditions*, and upon termination the provisions of the *General Conditions* shall apply.

#### VI Governing law and jurisdiction

This Subscriber Agreement, including the Subscriber User Documentation, shall be governed by the law of **England**. Any legal action or proceeding arising under this Agreement will be brought non-exclusively in the Courts of **England** and the parties hereby consent to the personal jurisdiction and venue of such courts.
